

# **Corporate Social Responsibility Policy Statement**

#### A - Introduction:

Even before the Indian Government's Companies Act 2013, Section 135 made CSR mandatory, Oerlikon Balzers Group has been involved in CSR activities in India. Since the inception of the company in 1994, our philosophy and core belief is that a company should contribute back to society what it draws from it. Our belief is that if we can make a positive difference to the world around us, we should start with our own neighborhoods around all our coating centers in India, even if it is in a small way. Oerlikon Balzers would strive to contribute to community development by working as a catalyst for social change, particularly in the local areas of its corporate operations.

OBIN's core values of Integrity, Team Spirit, Excellence and Innovation and the concept of Delivering Value to Customers, stakeholders and Society at large drive the CSR policy. ### **C - Modalities of Execution of Activities:**

### **D** – Implementation Schedule:

The above CSR activities are carried out in the current year as per schedules prepared and agreed between the company and the agencies carrying out the project activities. Such schedules may extend beyond the current FY.

### **E – Monitoring Process:**

The above CSR activities have been recommended by the CSR Committee and approved by the Board of Directors of the Oerlikon Balzers Group. At the Board meetings, the CSR Committee will submit the report to the Board stating the status of each of these activities, the total amount spent so far and the plan for the remaining period. The Chairman of the CSR Committee shall be responsible for monitoring of CSR Policy from time to time. The CSR Committee shall ensure that the surplus arising out of CSR activities shall not form part of the business profit of the Company.



#### F – Reporting

The Board of Directors shall ensure that the activities as are included in this CSR Policy of the Company are undertaken by the company and the Board shall ensure that the company spends, in every financial year, at least 2 per cent of the average net profits of the company made during the 3 immediately preceding financial years, in pursuance of this CSR Policy giving preference to the local area and areas around it where it operates, for spending the amount earmarked for CSR activities and the Board shall provide an Annual Report on the CSR Activities in the prescribed format outlining the company's CSR policy, including overview of projects or programs undertaken and a reference to the web-link to the CSR policy and projects or programs, the composition of the CSR Committee and average net profit of the company for last three financial years.

Further, it shall report details of CSR expenditure during the financial year including total amount spent for the financial year and amount unspent, if any, as also the manner in which the amount was spent during the financial year detailing the CSR Projects and Activities and the amounts spent on projects and programs specifying what were spent directly on projects and programs and what was spent on overheads and details of amount spent directly or through implementing agency (including details of the implementing agency).

The company will also ensure a responsibility statement of the CSR Committee that the implementation and monitoring of CSR Policy, is in compliance with CSR objectives and Policy of the company.

The Annual Report on CSR Activities will be signed by the CEO or the MD as also the Chairman of the CSR Committee.

The Oerlikon Balzers Coating India Pvt Ltd. was, is and shall remain committed to CSR as a core business value and every effort shall be made to ensure that the Group conducts its CSR in a manner compliant with requirements under Section 135 of the Indian Companies Act 2013 and the Rules there under.



#### **G- Amendment**

Any or all provisions of the CSR Policy would be subject to revision/amendment in accordance with the guidelines on the subject as may be issued from Government, from time to time. The Board reserves the right to alter in any manner whole or part of this Policy as and when necessary, subject however to the provisions of the Section 135 of the Act and Rules made thereunder.

The Corporate Social Responsibility Policy in its present form is approved by the Board of the Company at its meeting held on 20 March 2015 on the recommendation of the CSR Committee.
